THE HISTORY

Pennsylvania launched the EITC Tax credit program in 2001 to allow a small number of taxpayers to pay their state income taxes to local low and mid-income students to attend the school of their choice.

The Basics:

- EITC tax credits through The Central Pennsylvania Scholarship Fund (CPSF) are worth 90% of the taxpayer's bill.
- EITC tax credits are awarded on a first-come, first-serve basis, so being early is critical
- If you pay more than \$3,500 in PA state income taxes, annually, you can pledge your tax dollars through this program!



Sign pledge form early in the year (or NOW)



(SEPT/OCT)



Make your contribution before deadline on award letter



You can choose how your tax dollars are spent!



THE PROCESS

It's Simple, it's easy and it makes a difference in your community!

- Determine the amount of your PA tax liability (PA 40, line 12)
- Complete the pledge form (shown below) to hold your place in line
- An award letter and check request will be mail from CPSF.
- Send your contribution as directed by the CPSF letter.
- You will receive a K-1 (receipt of contribution) to file with your taxes for the 90% credit.
